The Newhall Land and Farming Company is processing a Vesting Tentative Tract Map (VTTM) 84536 that is situated in unincorporated Los Angeles County ("County") west of the City of Santa Clarita. The project proposes to develop the Entrada North project on approximately 438.6-acre area ("Project Site") with a vesting tentative tract map and related entitlements with 1,150 residential units and up to 304,700 square feet of residential-serving commercial uses (the "Entrada North Project" or "Project").
