A. Report from 5th District; Los Angeles County Supervisor's Office of Kathryn Barger - Stephanie English.

1. Sloan Canyon Road Traffic & Safety update - Julian Garcia.
2. Truck parking along Castaic Road - Julian Garcia.
3. Castaic Road Food Trucks - Email update.

- Sloan Canyon / Castaic Road - Julian Garcia: Update since May. Haven't heard from Daycare, but moving forward on Sloan. On Castaic Rd. re: pavement markings, there is no allowable that would not result in worsening of situation. Proposal and will email conceptual: Small Islands spread out throughout Median Lane. Ballards temporarily at beginning as pursue raised medians to follow. Council: Will there be an study or simulation on traffic movement as a result of conceptual/project? Does study show current turn data? Not yet, only at intersections. Can there be study of bollards installed truck movement prior to permanent median being installed? JG: Sure. Council: Please make part of record for this project. JG: Businesses will be notified. Only anecdotal contact at this point, not formal.
- East bound traffic on Sloan/L. Hughes cueing of trucks impeding exit of off ramp. Any specific time? Council: Afternoon. Doesn't matter what time. JG: Will focus at a.m. / p.m. peaks.
- Honors Ranch Development Project: Stephanie/Anish - Anish Saraiya - Addressing misconceptions due to Press Release. Project began 2016. Economic Development. Integration of and Support of the Castaic Community is Supervisor's priorities. Re: Housing comment in PR, that is entirety of SCV, not to this project. Trammel Crow Commercial Development engaged as potential developer for this project. Focuses on high wage industries and jobs to Castaic. Bio/Life Sciences, Warehousing, Logistics, Strong Retail component. Nexus to Castaic community. Infrastructure investment must be significant. Will require Developer to work with Community/Town Council and how development meets needs of Castaic community. Council: Will Hasley Canyon exit have changes made to ingress property. AS: Yes, access is critical part of development and will tie infrastructure to trips per day. Council: Traffic related inquiry. AS: Yes, Supervisor is very aware of traffic. Council: Tapia Canyon as an additional I-5 Fwy access point. Truck flow is critical. Critical to make Castaic Road to hook up to Magic Mountain Parkway. Gas Co. owned property mentioned. AS: Will reach out for info. on gas co. Council: Preliminary Site Plan available? AS: No, only high level discussions. Will see if can access and share with Council asap. Council: Clarification re: CEQUA environmental requirement. Will it be required later? AS: Yes, an appropriate environmental document would be done for any

proposal adapted to scale. Council: Castaic Creek is SEA protection. Needs to be considered. Also, boundaries would be most helpful if CATC could get map of actual boundaries of Castaic Creek. AS: Re: SEA and Castaic Creek impacts were part of the RFP as part of solicitation for developer/partner. County does have a pathway into developing into an SEA, but not sure if this is required to make this project viable. Will see if he can get map with boundary overlays to see.

- Council: County Health Department came out and inspected and food trucks are in compliance with all regulations. County's Mobile Food Team conducted visits. Council: Notified Social Media post about sidewalk vendor still conducting operations. Advised public to report this to Public Health and Supervisor's office to address as is not compliant activity.

- 4th of July: Stephanie: Hundreds of complaints before during and after the 4th Holiday. Encourage citizens not to use illegal fireworks. Calls on these days inundate the available resources and overwhelm first responders. Almost impossible to prevent/enforce. Response based upon i.e. Severity of fireworks i.e. M-80, injury?, Fire Risk, DA doesn't prosecute these crimes. Low level misdemeanor crimes. Wasting time to call in. Press conference June 27th, 9:30a near mall fire station. RE: School Resource Officers: Barger supports SRO's.

B. Report from 38th Assembly District; Assemblywoman Suzette Martinez Valladares - Patsy Ayala.

- Email update sent to Council Members. Misc. Bills being supported by Assemblywoman Valladares. Wild Fire Home Insurance working group adding commercial property owners as well.
