Projection Overview:

In accordance with Castaic Community Standards District (CSD) requirements, Section 22.44.137(e)(2)(g) of the Los Angeles County Zoning Ordinance Old Road Boat & service requests the review and support of a pending County of Los Angeles land use application for a. Conditional Use Permit to formalize the continued use of the 2.2 areas of flat area of the site for boat, RV, truck and other vehicle storage. This area will be screened from the public right of way along the property frontage of both The Old Rd and Villa Canyon road with screened fencing in conformance with Section 22.52.610 of the Zoning Ordinance. Tenant access will be via self-actuated gate facing The Old Rd. No onsite employees are needed for operation of the facility. No significant physical changes are proposed on the site.
